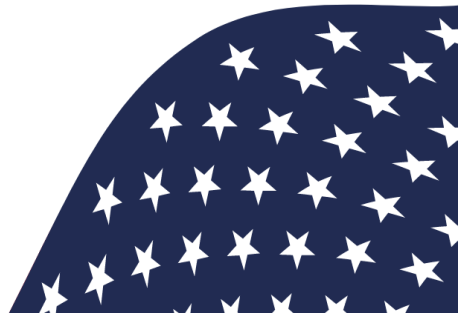

GEORGIA CITIZENS HAVE ACCESS TO SEVERAL CONVENIENT METHODS OF REGISTERING TO VOTE:

- Download, complete, and mail a voter registration application.
- You can go to your local county board of registrars' office or election office, public library, public assistance office, recruitment office, schools, and other government offices for a mail-in registration form.
- Registration is offered when you renew or apply for your driver's license at Department of Driver Services.
- College students can obtain Georgia voter registration forms, or the necessary forms to register in any state in the U.S., from their school registrar's office or from the office of the Vice President of Academic Affairs.

TO REGISTER TO VOTE IN THE STATE OF GEORGIA, YOU MUST BE:

- A citizen of the United States
- A legal resident of Georgia and of the county in which you wish to vote
- Be at least 17 1/2 years of age to register and 18 years of age to vote
- Not be serving a sentence for conviction of a felony involving moral turpitude
- Have not been found mentally incompetent by a judge

In the state of Georgia, you do not register by political party to vote in the state's regular primaries or general elections.

You may register to vote at any time. The last day to register for any election is 30 days prior to that election. Any mail-in applications must be postmarked by 30 days prior to that election. If you are not registered to vote, register today.

ABSENTEE VOTING BY MAIL

Any eligible registered voter may apply for an Absentee Ballot. Just complete and sign the Vote by Mail application. Then, mail, fax, email (as an attachment), or drop the Vote by Mail application off at your county registrar's office. After the Elections Office has received, reviewed, and verified your Absentee Ballot Application, an Absentee Ballot will be mail to your address between 22-29 days prior to the primary or election, or as soon as ballots are available prior to a runoff. You may apply for an absentee ballot no earlier than 78 days before any primary, election, or runoff. An application must be received no later than 11 days before the election, primary, or runoff to be processed.
