Georgia citizens have access to several convenient methods of registering to vote:

- Download and complete a voter registration application at voter.cherokeega.com
- Contact your local county board of registrars' office or election office, public library, public assistance office, recruitment office, schools and other government offices for a mail-in registration form.
- E-mail your request for a voter registration form to Voterhelp@cherokeega.com, or write us at Cherokee County Voter Registration, 2782 Marietta Highway, Suite 100, Canton, GA 30114. Please include your name and mailing address.
- "Motor Voter" registration is offered when you renew or apply for your driver's license at Department of Motor Vehicle Safety drivers license posts.
- College students can obtain Georgia voter registration forms, or the necessary forms to register in any state in the U.S., from their school registrar's office or from the office of the Vice President of Academic Affairs.

To register to vote in the state of Georgia, you must be:

- A citizen of the United States
- A legal resident of Georgia and of the county in which you wish to vote
- At least 18 years of age by election day
- Also, you may not register to vote if you are currently serving any sentence imposed by the conviction of a felony or if you have been judicially determined to be mentally incompetent.

In the state of Georgia, you do not register by political party to vote in the state's regular primaries or general elections.

You may register to vote at any time, but you must be registered by the close of registration prior to an election if you wish to vote on Election Day, i.e., the application must be postmarked by the voter registration deadline. If you are not registered to vote, register today.

ABSENTEE VOTING BY MAIL

Any voter registered in Georgia may vote absentee by mail. Just complete and sign the Vote by Mail application. Then, mail, fax, email (as an attachment), or drop the Vote by Mail application off at your county registrar's office. Request your mail-in ballot and get it back to your county registrar's office as soon as possible. Mail-in ballots can be requested no earlier than 180 days prior to the election and must be received by your county registrar no later than close of the polls on Election Day.
